In researching the Cemetery Trusts, I am in receipt of an attorney's letter RE: Estate of Myron Robie #1998-005, which stipulates:

This bequest is to be used as follows:

"the income therefrom to be used for perpetual care of the ROBIE LOT in said CEMETERY and any unused income annually to be used for the general care of said CEMETERY"

This is somewhat unique to the rest of the trusts and I interpret this to mean that if the Cemetery Trustees specify the amount of yearly funds will be required to maintain the Robie Lot, they can then request the remaining funds for general purposes.,  
Is this correct or are there additional restrictions due to the Perpetual Care nature of the trust?






