Be it known hereby, That I, Sherman Hobbs of Pelham in the County of Hillsborough and State of New Hampshire, do make and publish this my LAST WILL AND TESTAMENT.

After payment of my just debts, funeral charges and expenses of administration, I dispose of my estate as follows:

To my niece, Faith (Smalley) Abbott, one thousand dollars (\$1000.00).

To the First Congregational Church of Pelham New Hampshire, five thousand dollars (\$5000.00) in trust, to be known as the Ildie P. Hobbs Fund, to invest, re-invest and preserve said principal forever, and to use the income therefrom for whatever purpose the duly authorized officers of said church may deem expedient.

To the Pelham Public Library of Pelham, New Hampshire, five thousand dollars (\$5000.00) in trust, to invest, re-invest and preserve said principal forever, and to use the income therefrom for any purpose which the trustees may deem advisable.

To Fred L. Smalley, my cousin, all the real estate in the Town of Windham, N.H. owned by me at the time of my decease, meaning and intending to include the Jonas Buttrick Lot, so called, (12 acres) situated partly in Windham and partly in Pelham and adjoining the Elphage Landry farm.

To Alfred R. and Helen A. Lary jointly, the Couilliard Lot, so called, adjoining their land and land of Edith N. Spear with the old blaksmith shop thereon and all the contents thereof.

To Charlie Hobbs, son of C. Winthrop Hobbs, my old Grandfather's Clock in the living room of my home, so that it will remain in the Hobbs family.

To the Cemetery Trustees of Pelham, if provision has not already been made by me for the same, two hundred dollars (\$200.00) the income of which to be used for the perpetual care of our lot in the old cemetery.

To Angeline E. Foster, Ina B. Crowell, Eva Gertrude Simpson and Fred L. Smalley one thousand dollars (\$1000.00) each; and to Susan C. Simpson and Frank E. Simpson five hundred dollars (\$500.00) each.

The residue and remainder of my estate to be divided equally among the above mentioned persons, all of whom are my cousins, viz. -
