

BE IT REMEMBERED that I, CONSTANCE R. LANSEIGNE-CASE, of Pelham, State of New Hampshire, being of sound mind and memory, but knowing the uncertainty of this life, do make this my LAST WILL AND TESTAMENT, hereby revoking all former wills by me at any time heretofore made.

After the payment of my just debts and funeral charges, I bequeath and devise as follows:

(1) The sum of TEN THOUSAND AND 00/100 (\$10,000.00) DOLLARS to the Trustees of the Trust Funds of the Town of Pelham, New Hampshire, in trust, nevertheless, for the following uses and purposes and subject to the limitations and conditions hereinafter set forth, to wit:

(a) The Trustees shall receive, hold, manage and control the trust, except as hereinafter provided, which shall be known as THE LANSEIGNE CASE MEMORIAL SCHOLARSHIP FUND, shall collect the income therefrom, pay all expenses incidental to the care, operation and maintenance of the trust estate, and shall dispose of the net income therefrom as herein provided.

(b) The income from said trust is to be awarded annually, in whole or in part, to graduating students of Pelham High School, Pelham, New Hampshire, who plan to attend institutions of higher education and pursue a vocational-technical training.

(c) The recipients of said award or awards shall be designated by a Scholarship Committee consisting of the Principal of Pelham High School, or his designate, a Guidance Counselor of Pelham High School, and the Chairman of the Industrial Arts Department of Pelham High School. [I direct my Trustees to distribute said award or awards out of the income of said trust according to the majority vote of said Scholarship Committee.]

(d) In making their choice as to persons to be benefited, the Scholarship Committee shall be guided by the following criteria:

(i) The character of the individual which shall include dependability, honesty and adaptability.

(ii) The motivation, talent, and academic achievement of the individual which shall be above average.

(iii) The scholastic record of the individual which shall reflect an ability to succeed at a vocational-technical training.

(e) No portion of the principal of said trust shall be applied to any such award or awards.
