

Dear Scoutmasters:

H. Tracy Davis died on July 15, 1988 while serving as a Boy Scout summer camp leader in Rhode Island. The H. Tracy Davis Memorial Fund was established by his friends to memorialize his many contributions to the Pelham Boy Scouts.

Tracy was a strong believer in the goals and principles of Scouting and felt that every Scout should strive to become an Eagle Scout. The Trustees of the H. Tracy Davis Memorial Fund have determined that it would be a fitting memorial to Tracy for the Fund to sponsor or co-sponsor Eagle Scout Courts of Honor and Eagle Scout Projects.

In keeping with the forgoing decision, the Trustees of the H. Tracy Davis Memorial Fund have turned over all of the contributions collected by the Fund to the Trust Fund Trustees of the Town of Pelham to be invested and administered pursuant to the laws of the State of New Hampshire (RSA 31:19 et seq.).

At least once each year the Scout Committees of Pelham Boy Scout Troops 25 and 610 shall meet and determine how many Eagle Scout Courts of Honor and Eagle Scout Projects are planned for the ensuing year by their respective Troops. Income from the H. Tracy Davis Memorial Fund will be first allocated by the Scout Committees for the sponsorship or co-sponsorship of Eagle Scout Courts of Honor.

If no Eagle Scout Courts of Honor are anticipated for the ensuing year, or if the Courts of Honor that are anticipated will not require all of the income generated by the Memorial Fund, the income from the Fund may be allocated by the two committees to sponsor or co-sponsor Eagle Scout Projects.


Once the two Scout Committees have determined how the Memorial Fund income shall be spent, the Chairmen of the two Committees shall write a single letter signed by both to the Trust Fund Trustees of the Town of Pelham instructing the Trust Fund Trustees as to how and when the income from the H. Tracy Davis Memorial Fund shall be paid for the ensuing year.

It is recognized that in any given year only one Scout Troop may have an Eagle Scout Court of Honor or Eagle Scout Project. However, it is the intent of the Trustees of the H. Tracy Davis Memorial Fund that over the long term the income from the Memorial Fund will be distributed as equally as possible between both Troop 610 and Troop 25. It is also their intent that any income not spent in a given year will be carried over by the Town's Trust Fund Trustees and be spent by the Scout Troops in subsequent years for the two purposes stated herein.

The Trustees of the H. Tracy Davis Memorial Fund direct that whenever an Eagle Scout Court of Honor or Eagle Scout Project is sponsored or co-sponsored by the Fund, the printed program for the Court of Honor shall publicly acknowledge the sponsorship or co-sponsorship by the Fund.
